### LETTER FROM THE PRESIDENT

The Woodland Park Improvement Association, your neighborhood organization, marks the beginning of its 43rd year of existence this month. Incorporated in 1946, the organization has actually been in existence since the late 1920's. Over the years, as the need has arisen, residents interested in preserving the quiet enjoyment of this pleasant neighborhood have come forward on a pro bono basis, and given the time and energy necessary to maintain and preserve the special sense of community which has made this neighborhood a desireable and welcome place to call home. The organization has been active and aggressive in maintaining the character of the neighborhood, housing issues, zoning issues, physical improvements to the neighborhood, and in providing a sounding board for the opinion of its residents on matters directly affecting Woodland Park.

For 35 years, this organization has contracted for public sidewalk snow removal, at a nominal fee. We have done so again this year.

After a dormant period of more than a decade, several individuals contributed the time, services and money needed to resume the annual neighborhood-wide block party this past June. A number of local merchants donated goods for this party, with the Western Market being exceptionally generous. As a result, the cost to the neighborhood organization was nominal. Bill and Carol Frederick of West Woodland, and several volunteers who helped them, deserve special thanks for their organizational efforts.

The organization is presently negotiating with Wetmore's concerning the use of a small parcel of land withir the Woodland Park subdivision, which Wetmore would like rezoned to permit commercial In september, residents of Woodland Park overwhelmingly voiced their opposition to rezoning. However, nearly all respondents wanted the current condition of the lot changed and improved. In October, the officers and Board of Directors voted to negotiate, if possible, an agreement with Wetmore's, subject to city approval, which would allow limited, controlled use of the lot for employee parking only; would require landscaping subject to the approval of this organization; would contain effective sanctions for violation of the agreement; and would accomplish this without rezoning, thereby preserving the integrity of the neighborhood. This is a complex matter, as it involves prior litigation between WPIA and Wetmore's; the feeling and rights of contiguous property owners; the clear expression of the

membership of WPIA; and the city's right to regulate land usage within its borders. Long-time residents will recall thais dispute was the subject of litigation beginning in 1946, and several times thereafter. In the late 1970's, the city proposed to rezone a section of current residential lots within Woodland Park just west of the existing commercial district, changing them from residential to commercial. That proposal was also vigorously fought by your neighborhood organization, resulting in its defeat. The absence of effective neighborhood organizations in other parts of the city has permitted similar changes to occur there.

The continuation of these efforts, and with them the preservation and ongoing vitality of the neighborhood, depends on your willingness to become actively involved. First, pay your dues. The amount is minuscule, and block directors will be calling on you shortly. Second, the annual meeting will take place in March, 1990. The organization is in need of volunteers to direct some of these efforts, or chair committees to plan others. We would like to organize another block party in June. We would like to explore the feasibility of a swimming pool-community center facility similar to that in Pleasant Ridge. Even the organization of luminary distribution on Christmas Eve could use your help.

Many of you receiving this newsletter are new residents of Woodland Park, and to you we offer our warmest welcome and a special invitation to become active and continue this tradition of community involvement. To our long time members and residents, many of whom have called me wondering about these items, and more, thank you for your patience. This has been an extraordinarily demanding year for me, and time has been in short supply. I look forward to seeing all of you in March.

### SNOW REMOVAL BEGINS

After a number of extremely mild years, it appears that the law of averages is about to strike. Snow removal has already begun, making timely collection of your dues (\$11.00) critical. When your block director calls, please pay in cash or by check made payable to the Woodland Park Improvement Association.

Snow removal prices (\$8.00 of your dues) have not changed significantly for many years. The same family has been providing snow removal since 1955, and our survey of comparable services last year revealed that the cheapest alternative service would cost approximately six times as much per household. Snow removal on the public sidewalk greatly helps children on their way to school, individuals who are unable to clear their own walks, and contributes to the sense of neighborhood unity we all enjoy.

Please help your block director with timely payment and remember the block directors are all unpaid volunteers.

# TREASURER'S REPORT

Mike Francis, the former block director of Upper Woodland, is our new treasurer. He succeeds Richard Dalton, who did a fine job of reorganizing the finances of our organization. The monies have been deposited in a commercial checking account which pays a modest interest rate on a monthly basis and does not charge a service fee. Our cash balance is approximately \$2,800.00. Of this, a significant amount will be spent for snow removal, other amounts for luminaries. Expenses for the June party have not been compiled, but will probably total less than \$100.00. Collections were greatly improved during the last 3 years, resulting in the good condition of our treasury. We hope to obtain 100% collection to maintain the solvency of the organization.

# LETTER FROM THE PRESIDENT

The Woodland Park Improvement Association, your neighborhood organization, wishes you happy holidays and a joyous New Year's. As we begin our 66th year (44th since incorporating), some reflections on the benefits of this Association to our neighborhood seem appropriate.

The Association was organized in 1924, in response by the residents of this neighborhood to the State of Michigan's condemnation of the land now makes up southbound Woodward Avenue. The entire Woodward corridor at that time consisted of two lanes of today's northbound portion. When the state decided to widen Woodward Avenue, Ferndale's thriving business district lay in the middle of today's southbound lanes. The state's solution was to move the business district west to its present location, and replat the residential lots which then occupied it. Because there weren't many motor vehicles compared to today, and because the cost of condemnation was financially and politically costly, the state made no effective provision for parking for the newly-created business district. Those residential lots abutting the alleys on either side of Woodward were replatted to half-size lots. Because they were too small to build residences on according to city code, and because the zoning ordinance prohibited their commercial use, conflict with the businesses' need for additional parking was immediate.

Concerned residents of Woodland Park organized to prevent any further partitioning of their neighborhood, and our neighborhood organization was born. Over the years, concerned and educated residents have donated time and effort to maintain this pleasant neighborhood. When businesses tried to encroach into the existing residential lots in 1946, the Association filed suit in the Oakland County Circuit Court, obtaining a permanent injunction which has been upheld three times since.

In the 1970s, the Association successfully fought municipal attempts to rezone the residential lots immediately west of Woodward Avenue for commercial use, a change which might have sounded the death knell for the character of this neighborhood.

1980s, the Association, In the working with the city, contributed to the creation of a workable plan to control excessive through traffic resulting from the construction of the Reuther freeway. We still maintain an active, positive working relationship with Ferndale's city government today. We also recognize the need to encourage a stable, healthy, and educated business community along our periphery. Those neighborhoods which have protected their long-term interests active neighborhoods with organizations have seen negative consequences, including loss of control of some aspects of land use regulation within their borders. In the past year, residents of some of these neighborhoods have called to inquire about organizing their own associations.

The vitality of this neighborhood is directly dependent upon the willingness of its residents to pitch in and help. Your help is needed now. If you live on upper Drayton, lower Maplehurst, or Lewiston, a new block director is needed immediately. Yes, there are the inconveniences of collection and luminary But, with the distribution. investment of a few hours' time, you contribute to a long and effective tradition of activism which is directly responsible for keeping terrific neighborhood enjoyable and pleasant place to live. Call any officer or block director now. Your help is needed.

Happy holidays to you all, and we look forward to seeing you at the annual meeting in March, and at the summer party on June 19, 1991.

# LETTER FROM THE PRESIDENT

The Officers and Directors of the Woodland Park Improvement Association, your neighborhood organization, wish you happy holidays and a joyous New Year's. The Association begins its 68th year in January, making it one of the oldest continually operating neighborhood associations in the Detroit metropolitan area.

The Association, originally formed in the 1920s to protect the integrity of the neighborhood against condemnation and rezoning problems which arose from the widening of Woodward Avenue, has maintained an independent and active relationship with the City government, while at the same time striving to work with it for the common good of both the City and the neighborhood. Long-time residents will recall that the neighborhood organization has taken zoning and land usage issues to the Oakland County Circuit Court on several occasions, beginning in 1946. Over the years, the Association has opposed City efforts to rezone residential lots along Woodward Avenue for commercial purposes, which the Association believed would have a dramatic, negative impact on housing values in this neighborhood; has worked with the City to establish a system of traffic controls within the neighborhood, to reduce traffic passing through our neighborhood to access Woodward Avenue; and has worked, strictly on a volunteer basis, to instill and maintain a sense of neighborhood pride, involvement, and promotion for our common good. All of these efforts have been done on a purely volunteer basis, with no financial or pecuniary benefit to the individuals who have donated their time in an effort to make this neighborhood a better place in which to live. At our annual summer party in June, I had the opportunity to speak with an architect who specializes in community restoration, who was attending as a guest, together with several realtors. Each of them was impressed, and commented on several occasions, that ours is an intact and active family neighborhood with an obvious sense of community spirit. Each of them commented to me that they did not see this in

their own neighborhoods, or in other neighborhoods they were familiar with in many of the northern suburbs.

The Association, in addition to maintaining an active presence in municipal decisions which might affect our neighborhood, is always looking for ways to make the neighborhood better. We will provide snow removal again this year. In the wake of last March's snow/sleet/ice/freezing rain storm, which prevented our snow plow operator from removing the snow for a considerable period of time, many residents called me. Some were calls of complaint, many simply questions as to why the snow could not be removed. The Association canvassed 13 snow removal systems; 12 were unable to clear the snow, because of its heavy moisture content, followed by plunging temperatures which reduced it to cement-like ice. The only snow removal organization capable of clearing the ice had to bring in a back hoe, followed by a V-blade plow. The cost per household for this service would have been approximately \$75.00. We are striving, this year, to make alterations in our snow removal contract in contemplation of such a storm, but the National Weather Service indicates that a storm of identical characteristics comes along about once every ten years. If any of you have constructive suggestions on how to improve the snow removal service, please call me.

Negotiations with Wetmore's concerning the use of a small parcel of land within the Woodland Park subdivision, which Wetmore would like rezoned to permit commercial parking, continues. This parcel is the subject of a 1946 Circuit Court injunction forbidding its use as a commercial parking lot, and has been the subject of subsequent court actions. The Association has made a settlement proposal to Wetmore's, as Wetmore's is a valued and long-time commercial neighbor, and we expect resolution of this matter by spring.

From time to time, residents will call me suggesting that the Association consider a project or a service which would benefit the entire neighborhood. Some of these suggestions are of interest to the Association, but would require time and effort to implement. The Association is a volunteer group, and while your suggestions are always welcome, your willingness to backup your suggestions with time and effort, together with the Association's support, will greatly increase the chances of our being able to adopt your suggestion.

To the new residents of Woodland Park, we offer our warmest welcome and a special invitation to become active and continue this tradition of community involvement. To all of the residents of Woodland Park, we wish you a happy holiday and a joyous New Year's. We look forward to meeting with you in March, at our annual meeting, on a date to be announced.

# Letter From the President

The Woodland Park Improvement Association, whose members are your friends and neighbors, wishes you happy holidays and a joyous New Year's. Much has happened this past year in our neighborhood, and 1995 promises even more.

After 48 years we have reached a friendly agreement with Wetmore Tire over the use of Lot 489, the small, irregular lot behind and to the west of Wetmore's. The dispute began in 1924, when the State of Michigan widened Woodward Avenue to create its southbound lanes. Much of Ferndale's downtown, which was located there, was condemned. The remaining businesses were relocated on the west side of Woodward, on the edge of the Woodland Park subdivision. some of which was also condemned for the move. The Association fought all subsequent attempts to condemn additional residential lots, or to rezone them for commercial uses, fearing destruction of the neighborhood's residential character. The Association forced important concessions from the State, and in later years obtained injunctions from the Oakland County Circuit

Court forbidding use of the lots for commercial purposes. One injunction, issued in 1946, prohibited Wetmore's from using Lot 489 for commercial parking. Unfortunately, it did not clearly address its effect on future owners of Wetmore's. After nearly fifty years of dispute, several more court appearances, and a request from Wetmore's for rezoning to commercial status which has been pending since 1989, a settlement has been reached. The written settlement will permit Wetmore's a non-conforming use of Lot 489 for parking, contingent on City approval with restrictions as to use, hours, and appearance. The Association will participate in the drafting of the landscape plans. The agreement will be binding on all future owners of Wetmore's, regardless of the use to which the property might ultimately be put. Wetmore's, an old and friendly neighbor with an important job and tax base, will remain. The residential integrity of the neighborhood will be preserved against future commercial rezoning attempts.

Forces of change continue to pressure our neighborhood, however. National business interests are actively seeking properties for redevelopment along Woodward between 9 Mile Road

and 696. Our proximity to booming Royal Oak and our greater value-forprice real estate, mean that we must remain active and vigilant in neighborhood use and control issues if we are to maintain the family quality of Woodland Park. If Governor Engler supports construction of a new Tiger Stadium on the State Fair grounds, real estate values will soar and the temptation to rezone land along Woodward Avenue will escalate. Now, more than ever, your active support of the Woodland Park Association will permit us to anticipate these changes, deal with them realistically, and allow us to continue to preserve and build on the gracious residential character of our neighborhood into the 21st century. Please pay your dues when asked, and lend a hand with our allvolunteer organization. It's your neighborhood.

\$12.00, up from the \$11.00 fee for the past 9 years. We continue to conduct a periodic survey of snow removal services, including the neighborhood kids, and know that our service is far less costly than any of the 14 others surveyed. We make every effort to provide prompt, efficient snow removal on public sidewalks. If you have a problem with this service, please call any officer or director, listed below. We were able to settle the Wetmore dispute at no charge to the Association through donated legal services for the past 5 years. Timely payment of your dues will permit us to maintain a small, but prudent. cushion against similar problems in the future. There is one morepotential lot dispute heating up now. Average dues payment last year exceeded 90% of our residents, a testament to your confidence in Woodland Park.

# Summer Party



# Letter From the President

For seven decades, the Association has provided snow removal; aggressively fought against attempts to rezone portions of the neighborhood as commercial; fought in court to safeguard the residential quality of the neighborhood which contributes to its desirability and high resale

value; and has sought to promote a sense of common good and commitment to our neighborhood which helps to make it such a pleasant place to live.

The officers and directors who work to make the Association effective are all volunteers. Letter From The President

This letter marks my farewell note to all of my friends and former neigh-

bors in Woodland Park. After 15 years on West Woodland, Ellen and I and our boys have moved to 14 Mile and Evergreen, in Beverly Hills. The move was made with more than a little regret, although our immediate neighbors will probably be relieved to be free of secret forts and hidden passageways to friends' houses.

I am also sorry to be leaving the individuals who worked so hard to keep the neighborhood organization strong and active. I was involved with the Woodland Park Improvement Association for 14 of the 15 years I lived in the neighborhood; some of the block directors in the neighborhood have been involved longer than that. Many of the current officers and directors have been active for years. Other current residents of the neighborhood have given time and effort over the years. The organization still needs help, however. A new president must be elected early in 1998, to carry on the the Woodland Park Association. Woodland Park is the oldest continuous neighborhood association in Ferndale, and one of the oldest in the entire state. It was founded in 1924, partly to maintain the appearance of the neighborhood, and also out of concern that the neighborhood not be irreparably damaged by the State's widening of Woodward Avenue. At the time, Woodward Avenue consisted only of two lanes in what are today the northbound lanes. Ferndale had a

thriving downtown business located in what are now the southbound lanes of Woodward, Condemnation to widen Woodward Avenue removed many viable businesses. and left the remaining ones without adequate parking, a situation which continues today. In our automotiveoriented society, inadequate parking often means the death of businesses, which in turn brings pressure on homeowners in the form of higher property taxes to replace tax revenues lost from business failure. Twenty-five years ago, Royal Oak's downtown was struggling to stay alive. It benefitted from Birmingham's resurgence: when Birmingham became too pricey, business and people bought in Royal Oak. Royal Oak solved its congestion problem by developing

to accommodate its patrons, and the whole city benefitted. Ferndale, in turn, may benefit from Royal Oak's overheated prices, it it can also solve this problem. To do so, it will have to create more parking. Pressure will increase as Royal Oak's southeast corner of Woodward and 6% develops, and as the new stadiums are built on the north edge of downtown Detroit. If the State permits development of the State Fair grounds, demand for Ferndale property, and parking, will skyrocket. Woodland Park is located along some of the most commercially desirable property in Ferndale, all of it subject to these pressures. The Woodland Park Association has been the protector and watchguard for neighborhood zoning and land use issues since its first court action in 1946. But times are changing, and the Association will need someone

to lead it on these and other issues in 1998.

Woodland Park needs a new president.

After 11 years in this position, my time to step down has come. It's time for new leadership. The time demands are not all that great, probably between 10 and 20 hours per year. The organization is in good shape financially, has terrific organizers, a nearly full retinue of block directors, and the will to continue. What it needs is a new president. If you are interested, please call Carol Frederick, or any one of the individual officers or block directors whose names are listed in this newsletter. You will benefit, not just in a better neighborhood, but by getting to know your reighbors, learning to work with city officials (many of whom also live in this neighborhood), and from the knowledge that your efforts have made a difference. There are intangible benefits to participating in this organization that go far beyond mere property value. If you want a better community, give something of yourself.

Although this is "goodbye", I'll continue to see many of you. Our children still attend Harding Elementary (a great school), and I have offered to assist the Association resolve parking matters involving Wetmore's and the lot located on the south side of Maplehurst near Woodward. To all of you, thank you for the opportunity to work with you for a better community. I hope you have benefitted as much as I.
